## MEMORANDUM OF AGREEMENT TO EXTEND LEASE.

MEMORANDUM OF AGREEMENT made and entered into this 22nd day of December, 1921, by and between E. E. Chartier and Lavada Chartier, his wife, lessors, and C. C. Peterman, lessee.

ITEM: WHEREAS on the 25th day of November, 1921, a lease was entered into by the parties aforementioned covering the property described as:
