ASSIGNMENT OF CONTRACT.

WHEREAS, the Noco Mexican Oil Company is the owner of a certain oil and gas mining lease, located in Tulsa County, Okla., on premises described as

Southwest quarter (SW $\frac{1}{4}$) of section twenty five (25) township nineteen (19) north, range eleven (11) east, containing one hundred sixty (160) acres, more or less, and

WHEREAS, H. M. Baker is the owner of an undivided one-eighth interest in and to the oil and gas rights covering said premises, which interest the said H. M. Baker owns by virtue of a certain contract made between the Kanola Oil & Refining Company, H. M. Baker and the Noco Mexican Oil Company, dated February 28, 1921.

AND, WHEREAS, The said H. M. Baker desires to sell, and the Noco Mexican Oil Company desires to acquire, all the rights, title and interest of the said H. M. Baker in and to the oil and gas mining rights owned by him, as aforesaid, in and to said premises.

NOW THEREFORE, For and in consideration of the sum of Five Hundred dollars (\$500.00) in hand paid by the Noco Mexican Oil Company to the said H. M. Baker, receipt of which consideration is hereby acknowledged, the said H. M. Baker does hereby assign, sell, transfer and deliver to the Noco Mexican Oil Company, his full undivided one-eighth interest in and to the oil and gas mining rights covering the southwest quarter of section twenty-five, township nineteen north, range eleven east, Tulsa County, Oklahoma, containing one hundred sixty acres in the entirety, together with all right, title and interest of whatsoever character owned by him, and in connection with said leasehold interest, as well as all personal property, equipment, machinery and other property of whatsoever character on said premises, or used in connection therewith; it being the purpose of this agreement to convey all the interest of H. M. Baker owned in said premises under this agreement of February 28, 1921 aforesaid.
