COMPANY AGREEMENT.

Know all men by these presents, that we, Martha Daniels nee - Birney a new born Creek Freedman, roll no. 550, and Clifford B. Daniels, her husband, each of Tulsa, Tulsa County, Oklahoma have entered into the following agreement with the law firm of Spears, Franklin and Chappelle of Tulsa, Oklahoma, which Witnesseth:

That the said Martha Daniels nee Birney and her husband, Clifford B. Daniels do by these presents employ said firm of lawyers for the following purpose to-wit: To check up all accounts of Richard J. Hill as guardian of said Martha Daniels, nee Birney, and to ascertain what is due said Martha Daniels from said Richard Hill as such guardian, and cause same to be turned over to said Martha Daniels, both real and personal property; and to bring all actions that may be necessary, or such other steps as said attorneys may deem best to conserve the interest of said Martha Daniels and to bring such action or actions as may be necessary against the said Richard Hill, his sureties or any other person or corporations that may be liable to said Martha Daniels nee Birney by virtue of any act done, or omitted to be done in relation to the property real or personal, of said Martha Daniels, nee Birney, whether such action be based on contract or tort; The said Martha Daniels and said Clifford B. Daniels hereby agree to furnish on demand all necessary expense money:

And for and in consideration of the advice and service of said firm, rendered and to be rendered herein, we promise and agree to pay to said attorneys 20% of all money or lands that may be recovered to said Martha Daniels, nee Birney as a result of the efforts of said attorneys; and hereby authorize said attorneys to retain 20% of all money that they may recover for us or either of us:
