RELEASE OF MORTGAGE.

Know all men by these presents: Whereas, on the 30th day of June, 1920, a certain mortgage was executed by F. C. Hays and Mary Jane Hays, his wife, mortgagors, to the Central National Bank of Tulsa, mortgagee, for the sum of Fifteen thousand dollars (\$15,000.00) upon the following described real estate, viz:

Beginning at the southeast corner of the north half (N $\frac{1}{2}$ ) of the northwest quarter (NW $\frac{1}{4}$ ) of the southwest quarter (SW $\frac{1}{4}$ ) of section eighteen (18) township nineteen (19) north, range thirteen (13) east, running west 175 feet, thence north 315 feet; thence east 175 feet, thence south 315 feet to the point of beginning; and (it is the intention that this point of beginning shall be on the west side of the thirty foot right of way for road purposes running north and south along the East line of the twenty acres described above, and on the north line of the roadway running east and west.)
