## OIL AND GAS LEASE.

Agreement, made and entered into the 18th day of Septtember, 1922, by and between Russel I. Bilby and Nicholas V. Bilby, party of the first part, hereinafter called lessor (whether one or more) and W. L. Hollingsworth, party of the second part, lessee.

Witnesseth, that the said lessor for and in consideration of One dollars, cash in hand yaid, receipt of which is hereby acknowledged, and the covenants and agreements hereinafter contained on the part of lessee to be paid, kept and performed, has granted, demised, leased and let, and by these presents does grant, demise, lease and let unto the said lessee, for the sole and only purpose of mining and operating for oil and gas, and laying pipe lines, and building tanks, powers, stations and structures thereon to produce, save and take care of said products, all that certain tract of land situate in the County of Tulsa, State of Oklahoma, described as follows, to-wit:

> All of the south half of the northwest quarter and the northeast quarter of the northwest quarter of section twenty eight (£8) township nineteen (19) north, range fourteen (14) east and containing one hundred twenty acres, more or less, as the case may be, according to the United States survey thereof,

of section 28, township 19, range 14, and containing 120 acres, more or less.

It is agreed that this lease shall remain in force for a term of three years, from this date, and as long thereafter as oil or gas, or either of them is produced from said land by the lessee.

In consideration of the premises the said lessee covenants and agrees.

lst. To deliver to the credit of the lessor, free of cost, in the pipe line to which he may connect his welks, the equal one-eighth part of all oil produced and saved from said premises.

End. To pay to the lessor Two hundred and fifty dollars each year in advance. for the gas from each well where gas only is found, while the same is being used off the premises, and lessor to have gas free of cost from any such well for all stoves
