ORDINANCE No. 2339

An ordinance vacating Sixteenth Street between lot 5 in Block 2 and lot 1 in Block 3, between Fifteenth and Seventeenth Streets in Liberty Place (Maywood Addition) as shown in recorded plat of Liberty Place (Maywood Addition) City of Tulsa, Oklahoma, with certain reservations and declaring an emergency.

WHEREAS, a petition signed by all of the property owners owning property abutting on the street in the lots and blocks herein mentioned has been presented to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, asking that the street therein described be vacated and abandoned as a public street.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF TULSA, Oklahoma.

Section 1: That the street running East and West between Lot five in Block two, and lot one in Block three between Fifteenth and Seventeenth Streets in Liberty Place (Maywood Addition) as shown in recorded plat of Liberty Place (Maywood Addition) City of Tulsa, Oklahoma, be and the same is hereby vacated and abandoned as a public street of said city. Provided, however, that the City of Tulsa hereby reserves and shall retain forever, the right to construct, reconstruct, repair, maintain and operate sanitary sewers and other appurtenances thereto appertaining now located in said street or which of necessity should be constructed or maintained in said streets with the right of ingress and egress over said premises for the purposes above indicated, over and above that portion of the above described street included in the South 7' (seven feet) and 6" (six inches) thereof and described as a strip of land bounded by a line commencing at the Northwest corner of lot 1, Block 3, Liberty Place (Maywood Addition) City of Tulsa, Oklahoma, running thence east along the north line of said lot 1, Block 3 to the Northeast corner of said lot; running thence in a northerly direction, and
