WITNESSETH: That for and inconsideration of the mutual covenants, agreements and stipulations hereinafter set out first earties sell and second party buys the following described property in the City of Pulsa, Tulsa County, Oklahoma:

Lot two (2) Block four (4) Gillette-Hall addition to the City of Tulsa according to the duly recorded plat thereof, together with and including all buildings and improvements thereon

for a consideration and purchase price of \$5500.00, which said sum second party agrees to pay to first parties, their heirs or assigns, in the following manner, to-wit: \$1000.00 cash in hand paid upon the execution of this agreement the receipt of which is hereby acknowledged by first parties.
