

be in any way liable to any person by reason of acting upon such evidence of ownership, and the right to do so shall not be affected or abridged by any kind or character or notice.

7. That the management and control of the Express Trust shall be vested in the Trustees herein appointed, or their successors.

8. The said Trustees, or their successors, or appointees are hereby authorized to engage in and carry on the business of drilling and exploring for oil and gas, as fully as any individual might do when acting for himself; to buy, sell, deal in, own, operate, mortgage, transfer, assign and exchange oil and gas leases; to engage in refining, treating, distilling, manufacturing, piping, storing and handling natural gas and all the products of natural gas and petroleum; to construct, equip, own and operate plants, for the manufacture and sale of casinghead gas, gasoline, and all the products of casinghead gas, and for such purposes to buy, own, operate, construct, build, acquire and maintain tanks, tank cars, refineries, and all other machinery, appliances, and equipment necessary, or in any manner necessary or incident to the proper and successful conduct and management of the said business; to drill and prospect for oil and natural gas, to drill, own, operate and control oil, gas and water wells, to acquire, *exchange location or condemn* by purchase, or in any other legal manner any and all land necessary or incident to the proper conduct and management of the said business, to receive, own, hold, use, operate, lease, supply or otherwise dispose of oil and gas leases, mining rights, deposits of mineral, rock, coal, earth, and water, to buy, own, operate, construct, build, sell, mortgage, or lease telephone and telegraph lines in connection with the production, refining, disposition and sale of oil and gas and all their products, to buy, build, ^{own} operate, lease and construct oil, gas and water pipe lines, and all power stations and equipment necessary, or incident to the transportation of oil and natural gas and all their products; to buy, own, lease, acquire, sell or mortgage, all the necessary equipment for operating a casinghead gasoline plant, to buy, sell, and otherwise dispose of gasoline made from casinghead gas, to sell, lease or otherwise dispose of property used in connection with the business of producing and disposing of and manufacturing oil and gas and their products; to acquire either by purchase or otherwise, and own stock and securities of this trust or other companies or corporations, and may sell and dispose of the same, to incur indebtedness in such amounts as may be deemed necessary by the said Trustees, or their successors or appointees, for the purposes for which this Trust is organized; and to evidence such indebtedness by bill of sale, mortgage, deed of trust, or any other evidence of indebtedness, on any or all, of the property or properties of this trust, and any or all of the rights, franchises and privileges of this Trust, as may be necessary for or incident to the successful management and conduct of the business of this trust, not in conflict with the constitution and laws of the United States, and the constitution and laws of the State of Oklahoma.

9. That the trustees, or their successors in interest, shall hold the legal title to all property at any time belonging to this Trust, and they shall have absolute control, management and disposition thereto and shall likewise have absolute control of the conduct of the business of this Trust, and the enumeration of specific duties shall in no wise be construed as a limitation upon general powers herein conferred.

10. That the Trustees shall have authority to make all such contracts as they may deem necessary incident to or expedient for the successful conduct of the business to make, execute and deliver bonds, transfer orders, division orders, deeds, releases, mortgages, or any other instruments of writing in any wise connected with, growing out of, or incident to the proper and successful conduct of the business herein authorized; to confer, by way of substitution, such power and authority on such officers as they may appoint;
