IN THE DISTRICT COURT OF TULSA COUNTY

In the matter of the application of Louis D. Lewkowitz, Ida B. Lewkowitz, Samuel L. Lewkowitz and Bessie F. Lewkowitz, asking for an order changing their names.

D E C R E E.

Now on this 21st day of October, 1922, the same being one of the regular judicial days of the June, 1922 term of this court, the above entitled matter came on to be heard on the application of the above named petitioners, asking for an order of this court approving their action in dropping and changing their surname from Lewkowitz to Lewk; and

It appearing to the court that a notice of said application has been given by publication in the Tulsa Daily Legal News, in all issues from October 18th, to October 20th, 1922, both inclusive, and it further appearing to the court, that no objections have been filed to the granting of the order, as prayed for; and it further appearing to the court that the petitioners would be greatly benefitted in changing their names from Lewkowitz to Lewk.

It is therefore ordered, adjudged and decreed by the court that the action of Louis D. Lewkowitz, Ida B. Lewkowitz, Samuel L. Lewkowitz and Bessie F. Lewkowitz in changing their surnames ^{from} Lewkowitz ^{to} Lewk, and the same is hereby approved.

It is further ordered that a certified copy of this decree, upon being recorded in the office of the County Clerk of Tulsa County, Oklahoma, or in any other county or state in which any of said petitioners own property or have an interest therein shall be sufficient to transfer and convey same to the said petitioners under the surname of Lewk, and that any - all instruments of transfer and conveyance executed by said petitioners or any of them under and by the surname of Lewk shall and hereby does convey their interest therein with as full force and effect as though same had been regularly and properly executed under name of Lewkowitz, and that from and after the entry of this order and the recording of same, the said applicants herein shall bear the name of Louis D. Lewk, Ida B. Lewk, Samuel L. Lewk and Bessie F. Lewk.
