Comes now V. H. Biddison of Tulsa, County, Oklahoma, who being first duly sworn upon his oath, states:-

That he is and has been for 4 years a resident of Tulsa, Tulsa County, Oklahoma. That he is an attorney at law and that on the 6th day of November, 1920, at the request of Allen Elliott, affiant drew a certain real estate mortgage, said mortgage being in the sum of Five Hundred dollars (\$500.00) and filed of record in book 353, page 335 of the records of Tulsa County, Oklahoma.

Affiant would further state that this mortgage, through inadvertence and oversight, failed to contain and have inserted therein the name of the mortgagor and the name of the mortgagee, and further that said mortgage drawn failed to contain and have inserted therein the name of the county in which said property described in said mortgage is situated.
