HAVE GRANTED: SOLD AND CONVEYED, and by these presents do grant, sell and convey unto the said Mrs Sallie Taylor of the County of Tulsa, State of Oklahoma, all that certain piece, procl or tract of land lying and being situted in Tulsa County, Oklahoma and being lot 12 in Graceland section, containing 462 square feet, be the same more or less out of Rose Hill Burial Park as more fully appears frommap of said Burial Park hereby referred to and made a part hereof.
