It is further stipulated and agreed that the lessor, Sandy Johnson, shall have the right to reside in the principle dwelling now on that portion of his land known as the homestead, and reserve to himself one (1) bedroom in said dwelling and at such times as he does not occupy the same the second party may so do. It is further stipulated that said Sandy Johnson may occupy the whole of said house during the summer vacations and such times as his daughters are not in school and at such times the second party agrees to occupy the other dwelling on said premises.

The first parties hereto agree that second party shall have peaceable possession of said premises during the term hereof as provided in this lease.
