That the grantor in said deed was identified to them as being Riley Fulsom, the true allottee of the above described lands and the fee owner of same at said date. That the negro who executed said deed was a tall, dark brown man with course hair and appeared to be about 45 or 50 years of age at said time. That he was then and there identified as said Riley Fulsom by S. J. Jove and Dinah Grayson, both being Creek Freedmen and being dead at this time.

That subsequent to the 4th day of August, 1908, he and D. A. Skillen, grantees in first described deed, conveyed their interests in good faith to one Oscar K. Eysenbach of Tulsa, Oklahoma. That subsequent to the conveyance to the said Eysenbach this affiant has discovered that the negro who was identified to him and Skillen as being the allottee Riley Fulsom, was in truth not the said Fulsom at all but was an imposter and that the real Riley Fulsom was at said time, 4th day of August, 1908 dead. That long prior to his death the said Fulsom, the allottee of said lands described, was confined in the State Penitentiary at Little Rock, Arkansas, and that he died while an inmate thereof.
