

order of this Court Nunc Pro Tunc, correcting and amending so as to conform with the true facts an order of this Court heretofore entered on the 12th day of July, 1921, said order approving, under the provisions of Section 9 of the Act of Congress of May 27, 1908, a warranty deed executed on June 10, 1921, by an adult full blood Creek Indian, to-wit, Polly Grayson, nee Beaver, nee Stidham, said warranty deed conveying to said John P. Hayden and B. F. Whitehill all of the right, title and interest of said Polly Grayson, nee Beaver nee Stidham, in the following described premises, situate in Tulsa County, State of Oklahoma, to-wit:

Northwest quarter of Northeast quarter and the North Half of Northwest Quarter of Section 21, Township 19 North, Range 10 East,

and the Court being fully advised in the premises finds that through inadvertence and mistake said order mis-describes the roll number of said Polly Grayson, the grantor, in said deed, and, also, contains the following paragraph:

" It is further ordered, considered and adjudged by the Court that in token of this approval and ratification there be endorsed on the face of said deed, the words; " Approved in open Court this 28th day of June, 1921, together with the signature of the Judge of this court and the seal thereof."

whereas in truth and in fact it should contain the following paragraph:

" It is further ordered, considered and adjudged by the court that in token of this approval and ratification there be endorsed on the fact of said deed, the words: " Approved in open court this 12th day of July, 1921," together with the signature of the Judge of this court and the seal thereof."

and the court being of the opinion that said order should be corrected nunc pro tunc so as correctly to describe the roll number of said Polly Grayson and so as correctly to show the notation made by said Court on said deed,

IT IS, THEREFORE, ORDERED, CONSIDERED, ADJUDGED AND DECREED BY THE COURT that said order of this Court, heretofore entered on July 12, 1921, approving under section 9 of the Act of Congress of May 27, 1908, said warranty deed from Polly Grayson, nee Beaver nee Stidham, to said John P. Hayden and B. F. Whitehill, be corrected and amended so as to read;
