

said petitioner inherited any interest from said Katie Beaver. It is the intention of said petitioner to pass the same by warranty deed hereinafter described; that on the 10th day of June, 1921, said petitioner executed in favor of B. F. Whitehill and John P. Hayden a warranty deed, conveying to said grantees all of the right, title and interest in the above described premises; that said deed was made for the consideration of four hundred (\$400.00) Dollars; that said consideration, as heretofore found, is fair and just and that said deed should be approved under the authority vested in this court by section 9 of the Act of Congress of May 27, 1908.

FIFTH

That said Jennie Deerhead, the allottee of the premises above described, died a resident of what is now Hughes County, Oklahoma, and that this Court has jurisdiction of the settlement of the estate of said deceased allottee.

IT IS THEREFORE ORDERED, CONSIDERED AND ADJUDGED BY THE COURT that said deed executed by said Polly Grayson, nee Beaver, nee Stidham, on the 10th day of June, 1921, conveying to said B. F. Whitehill and John P. Hayden all her right, title and interest in the above described premises, situate in Tulsa County, Oklahoma, be, and the same is in all things approved and ratified, approved under the authority vested in this Court by Section 9 of the Act of Congress of May 27th, 1908.

It is further ordered, considered and adjudged by the court that in token of this approval and ratification there be endorsed on the face of said deed, the words: "Approved in open Court this 12th day of July, 1921," together with the signature of the Judge of this court and the seal thereof.
