said petitioner inherited any interest from said Ratie Beaver. It is the intention ofsaid petitioner to pass the same by warranty deed hereinafter described; that on the 10th day of June, 1921, said petitioner executed in favor of B. F. Whitehill and John P. Hayden a warranty deed, conveying to said grantees all of the right, title and interest in the above described premises; that said deed was made for the consideration of pour Hundrod (§400.00) Dollars; that said consideration, as heretofore found, is fair and just and that said deed should be approved under the authority vested in this court by section 9 of the Act of Congress of May 27, 1908.

## PIPTH

That said Jennie Deerhead, the allottee of the premises above described, died a resident of what is now Hughes County, Oklahoma, and that this Court has jurisdiction of the settlement of the estate of said deceased allottee.

IT IS THEREFORE ORDERED, CONSIDERED AND ADJUDGED BY THE COURT that said deed executed by said Polly Grayson, nee Beaver, nee Stidham, on the 10th day of June, 1921, conveying to said B. F. Whitehill and John F.
