NOW, THEREFORE, for the purpose of perfecting and correcting the attempted release of said real estate mortgage so executed on the 10th day of August, 1916, and the indebtedness thereby secured having been paid unto the said Merchants & Planters Bank, the said mortgage dated August 10th, 1915, to secure an indebtedness of Seven Hundred (\$700.00) Dollars, as therein set out and recorded in said Record Book No. 183, at Page No. 173 thereof, in the offices of the County Clerk of Tulsa County, Oklahoma, in, to and upon the above described land is hereby fully released and discharged.
