construct, reconstruct, repair, maintain and operate sanitary sewers and other appurtenances there to appertaining now located in said street or which of necessity should be constructed or maintained in said streets with the right of ingress and egress over said premises for thepurpose above indicated; that the city of Tulsa may allow public service corporation, companies, individuals or itself to construct, maintain and operate facilities for public utilities and including poles, wires, pipes, conduits and other necessary accessories: and.

Provided further that the above vacation is made subject to the conditions and provisions of Paragraph 11 of Section 6. Article 11 of the Charter of the City of Tulsa.

SECTION 2. That all ordinances or parts of ordinances in conflict with the provisions of this ordinance insofar as such conflict exists are hereby repealed.

That an emergency exists for the preservation of the public welfare and safety by reason whereof this ordinance shall take effect from and after its passage, approval and publication.

PASSED, and the emergency clause ruled upon separately and approved this 27th day of October, 1922.
