WITNESSETH, That in consideration of the sum of Fifteen Hundred and No/100 DOLLARS the receipt whereof is hereby acknowledged, said party of the first part, does, by these presents grant, bargain, sell, and convey unto said parties of the second part their heirs, executors or administrators, all of the following described real estate, situated in the County of Tulsa, State of Oklahoma, to-wit:

Lot ten (10) in Block One (1) of the subdivision of a part of Block Five (5) of Terrace Drive Addition to the city of Tulsa, County of Tulsa, state of Oklahoma, according to the recorded plat thereof.
