Price being first duly sworn on oath states that he is a resident of Tulsa, Oklahoma, and has been a resident thereof continuously for the past twenty five years; that he was familiar with the location and status, in the year 1902, of that certain tract of land within the original townsite of Tulsa, then Indian Territory, described as lots 1, 2 and 3 of Block 194 thereof which was conveyed by patent dated August 11, 1902, by the Muskogee or Creek Nation to David Schuttler, which land, on July 23, 1902, had been conveyed by warranty deed by David Schuttler , a single man, to P. W. Cunningham that your affiant was well acquainted with David Schuttler as well as with P. W. Cunningham at the time of these transactions.

Your affiant further states that he knows that the said David Schuttler was in actual possession of lots 1, 2 and 3 of Block 194 of the original townsite of Tulsa
