Upon failure to comply with either of these conditions, covenants and agreements, it is agreed that the owner of this mortgage may pay the said taxes or agreedments, or the cost of such insurance, and the amount so paid shall bear interest at the rate of ten per cent per annum from the date of payment, and said sum or sums so paid shall be immediately due and payable, and shall be an additional lien upon said real estate, and be secured by this mortgage, and may be collected in the same momner as the principal debt hereby secured:

That in case the second party, its successors or assigns, shall hereafter appear in any of the land departments of the United States Government, or in any court or tribunal whatever, to defend the title or possession of the mortgaged real estate or the lien thereon, or appear in any court to prove the mortgage debt, all the costs and expenses of such appearance, together with a reasonable attorney's fee, shall be allowed the second party, its successors or assigns, and such costs, expenses and attorney's fee, shall bear ten per cent interest from the date of the payment of said second party, its successors or assigns and shall be an additional lien upon the mortgaged real estate, concurrent with and collected in the same manner as the balence of the mortgage debt hereby secured;
