## DECLARATION OF TRUST

That on October 17, 1921, the said James F. Baldwin and Edna C. Baldwin, made, executed and delivered to Rex H. Winget, Trustee, a certain warranty deed covering,

City of Tulsa, Oklahoma, according to the Recorded Plat thereof,
