FARM MEASE

WITNESSETH: That for and in consideration of the covenants and agreements hereinafter made, the party of the first part has let, leased and decised, and does by these presents let, lease and demise unto the party of the second part for agricultural purposes for the term of five years fromand after the 1 day of January 1925 the following described tract of land lying in Tulsa County, Oklahoma, to-wit;

S. E. 1/4 of Section 31 Township 19 North Range 10 East

In consideration of the use of said tract of land for the term stated, said party of the second part hereby agree with said Frank Hash , that he will , during the term stated, thoroughly cultivate said land in a good and farm like manner, doing the preparing of ground, plowing, planting, cultivating and harvesting at the earliest and proper seasons, or, failing to do so, said party of the first part may hire men and teams necessary to do the needed work at the proper times and seasons and the expense so incurred shall be a lien on the pertion of crop, otherwise due said party of the second part.

Said party of the second part further agrees that he will not damage, abuse nor destroy any of the fencing or other improvements connected with said lands, but during the term thereof will keep the same in as good repair as when received, reasonable wear and tear excepted, and in case of failure to do so shall be liable to said Frank Nash out of said crop for the reasonable damage thereto.
