Said party of the second part agree that he will pay said Frank Nash two hundred and twenty dollar per year in advance for the use of said lands, as herein agreed upon \$220 to be paid on delivery of this lease and \$220 Jan 1/24 and every year thereafter on the first of January each year until the full sum of \$1100 has been paid for the use of said land for said five years.

This contract terminates on the 31 day of December 1927, and said party of the second part agrees that without further notice ( all notice required by law being expressly waived) he will deliver to said Frank Nash the possession of said land and improvements therewith connected.
