THIS INSTRUMENT Made this 18th day of July, A. D. 1922 between May Rosell and P. D. Rosell her husband of Tulsa County, in the State of Oklahoma, of the first part, and H. E. Hanna of the second part.

WITNESSETH, That the said parties of the first part, in consideration of the sum of One dollar and other good and valuable considerations, the receipt whereof is hereby acknowledged, and the further consideration and as a condition of this deed to which the grantee herein by accepting this deed assents and agrees: that the lot or lots hereby conveyed shall not within a period of ten years from this date be used for any other than residence purposes; that no residence that shall cost less than \$6000.00 including subsidiary buildings and improvements shall be built on the lot or lots hereby conveyed; that one residence only shall be built on said lots, that no building or any part thereof, except steps or entrance approach without roof shall be built or extend within 30 feet of the front lot line or closer than ---feet of the side street line and no garage, servant's house or other subsidiary buildings shall extend within ninety
