ORDER APPROVING FINAL REPORT OF ADMINISTRATION AND DEGREE
OF HEIRSHIP AND DISTRIBUTION.

Now on this 12th day of April 1920, the above matter coming on for hearing upon the final report of the administrator and upon his petition for approval of the same and for a degree of heirship and distribution and after examining said report and hearing the evidence introduced in behalf of the same and being fully advised the Court finds:

1. That due and legal notice has been given for the final hearing of this matter as contemplated by the laws of the State of Oklahoma, as well as an act of Congress approved June 14th, ¹⁹¹⁸ public No. 172, by publication of notice for four successive weeks in the Broken Arrow Ledger-Democrat; first of said notices being given on the 12 day of February, 1920, and the last being given on the 4th day of March, 1920, and by posting in three public places in Tulsa County, Oklahoma, one of which notices was posted in the City Hall where the County Court is held; and that said publication and posting is in proper form and the same is therefore approved by the Court, affidavit of said posting and publication being on file in this Court.

2. The Court further finds that the said administrator, C.B. Hailey, has executed his said trust with fidelity and that said final report should be approved.

3. The court further finds that said Rosa Chisholm was a Creek Indian of the full-blood being enrolled opposite Roll No. 845; that she died intestate in Tulsa County Oklahoma, on the 27th day of October, 1918, being a widow at the time of her death, her husband Anderson Chisholm having died several years previous thereto; that she left her surviving as her sole and only heirs her three daughters named as follows, Pauline Chisholm, Roll No. 9474, Minnie Chisholm, New Born Creek Indian, #443 and Lena Chisholm who was not enrolled, but who was born April 25th, 1907.

4. The Court further finds that said Rosa Chisholm was seized and possessed of the following real estate in Tulsa County, Oklahoma;

The southwest quarter of section 24 township 18 North,
range 13 east; the southwest quarter of the same being
her

homestead from the Creek Nation, and by virtue of the law of descent and distribution, to-wit: The Laws of the State of Oklahoma and the Act of Congress approved May 27th, 1908, said land descended to and become vested in the children heretofore named in the following proportions, to-wit: The north half of the southwest quarter and the ^{southeast} ~~southwest~~ quarter of the southwest quarter less about three acres in the southeast corner thereof used for church purposes, all in said section 24, township 18 north, range 13 east, Tulsa County, Oklahoma, to said Pauline Chisholm, Minnie Chisholm, and Lena Chisholm, equally or an undivided one-third interest each therein; The southwest quarter of the southwest quarter of section 24, township 18 north, range 13 east, Tulsa County, Oklahoma,
