Province of the first part(hereinafter called party of the first part, whether one or more) and L.K. Barron, of second part, (hereinafter culled party of the second part, whether one or more,

WITH SECTH: That the party of the first part, for and in consideration of the rents, covenants and agreements hereinafter contained, and by these presents, denise, lease and rent, for a periof of 17 months from the lst day of August ,1922, to the party of the second part, the following described property, to-wit:

> The downstairs room in the brick bilding located on lot 18 block 42, of the original town of Broken Arrow, Tulsa County, Oklahoma, and in addition that to second party shall have the free use of the vacant part of said lot and equal privileges thereon with the other eccupants of the building thereon.

The party of the second part, for and inconsideration of the use and possession for said pariod does hereby agree to pay unto the party of the first part, the sum of \$765.00 seven handred sixty five dollars, said sum to be paid in the following amounts and at the times therein designated, to-wit:
