they will warrant and defend the same in the quiet and pencable possession of said party of the second part his heirs and assigns, forever, against the lawful claims of all persons whomseever.

Provided, always, and this instrument ismade, executed and delivered upon the following conditions, to-wit:

First, said F.J.Hoot, Julia A., G.T. and anna Hoot and justly indebted unto the said party of the second part in the principal sum of sixteen thousand dollars, lawful money of the United States of America, being for a loan thereof made by the said party of the second part to the said F.J., Julia A.
