Now, therefore, know all men by these presents, that for and in consideration of the premises and the exercise of their said rights under said lease, does hereby give notice to the said lessors that they have and do hereby release all their rights under said lease, and that they have removed their property from said premises, and do hereby surrender possession of the same unto said lessors, their heirs, assigns and legal representatives; the purpose being to release unto the said lessors all further rights under said lease, and surrender said premises and all rights therein to them, their heirs, assigns and legal representatives.
