## ASSIGNMENT OF OIL AND GAS LEASE.

Sullivan all its right, title and interest of the original lessee and present owner in and to the said lease and rights thereunder in so far as it covers the above described tract, together with all personal property used or obtained in connection therewith to C. T. Sullivan and to her heirs, successors and assigns,

And for the same consideration, the undersigned for itself and its successors and representatives does covenant with the said assignee, her heirs, successors or assigns, that it <sup>is</sup> the lawful owner of the said lease and rights and interest thereunder, and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that said right <sup>and</sup> interest and property are free and clear from all liens and incumbrances, and that all rentals and royalties due and payable thereunder have been duly paid.
