OKLAHOMA FARM MORTGAGE.

This indenture, made this twenty seventh day of November, in the year of our Lord one thousand nine hundred twenty two, by and between T. C. Posey a single man, of the County of Tulsa, and State of Oklahoma, hereinafter known as party of the first part, and Commerce Trust Company, a corporation, of Kansas City, Missouri, party of the second part:

Witnesseth: That the said party of the first part, for and in consideration of the sum of Thirty five hundred and no/100 dollars, the receipt whereof is hereby acknowledged, has granted, bargained and sold, and by these presents does grant, bargain, sell, convey and confirm, unto said party of the second part, and to its successors and assigns, forever, all of the following described real estate, lying and situated in the County of Tulsa, State of Oklahoma.

The south 6.79 acres of lot five (5) and lot six (6) and lot seven (7) and northeast of the southwest of section six (6) township sixteen (16) N. range fourteen (14) east, containing 126.79 acres more or less.

Of the Indian Meridian, containing 126.79, acres, more or less, according to Government survey.

To have and to hold the same: With all and singular the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, and all rights of homestead exemption, unto the said party of the second part, and to its successors and assigns forever. And the said party of the first part does hereby covenant and
