DECLARATION OF TRUST OF THE REEDY-BOYLES-KOCH

OIL AND GAS COMPANY; AN EXPRESSED TRUST.

This agreement made and entered into this 9th day of December, A.D. 1922, by and between W. M. Reedy, F. A. Boyles, A. G. Koch, F. W. Koch and R. L. Koch, all of the State of Oklahoma, together with their successors under this agreement hereinafter designated as "Trustees".
