FARM RENTAL CONTRACT.

This agreement, made and entered into this 2nd day of January, 1923, by and
between Ella McIntosh, nee Haikey, and Ben McIntosh, her husband of Broken Arrow,
Oklahoma, party of the first part and A.L. Routh of Broken Arrow, Oklahoma, party
of the second part.

WITNESSETH: That for and in consideration of the covenants and agreements
hereinafter made, the party of the first part has let, leased and demised, and does
by these presents let, lease and demise unto the party of the second part, for
agricultural purposes for the term of five years from and after the third day of
January, 1923, the following described tract of land lying in Tulsa County, State of
Oklahoma:

The southwest quarter (SW $\frac{1}{4}$) of the southwest quarter
(SW $\frac{1}{4}$) of section thirty three (33) township eighteen
(18) north, range fourteen (14) east, containing 40
acres more or less.

The said party of the second part for the use of said land, agrees to pay to the party
of the first part, as rent the sum of fifty (\$50.00) dollars per annum during the term
