This indenture, made the 10th day of February, A.D. 1923, between M. C. Corby and Henrietta Corby (husband and wife) of Tulsa of the County and State aforesaid, as parties of the first part, and The Grodgie State Savings Association of Savannah, a corporation duly chartered under the laws of the State of Georgia, and having its principal office and place of business in the City of Savannah, Chatham County, Georgia, as party of the second part.

Witnesseth, that the said parties of the first part have mortgaged and hereby mortgage to the said second party, its successors and assigns, the following described real estate and premises, situate in the County of Tulsa, State of Oklahoma, to-wit:

with all the improvements thereon and appurtenances thereto belonging, and warrant the title to the same.

This mortgage is given to secure a loan of thirteen hundred (\$1300.00) dollars this day made by said party of the second part to said parties of the first part, evidenced by the note and contract or obligation of said M. C. Corby and Henrietta Corby of even date herewith, conditions to pay said Association on or before the 1 last business day of each and every month until sixty (60) monthly payments have fallen due and been paid, the sum of twenty seven and 06/100 (\$27.06) dollars, (which is made up of the sum of twenty one and 66/100 (\$21.66) dollars, as installments of principal, and five and 40/100 (\$5.40) dollars as installments of interest upon said loan) and to secure all other covenants and conditions in said note and contract set forth, reference to the same being hereby expressly made.

It is expressly agreed and understood by and between the said parties hereto that this mortgage is a first lien upon said premises, that the said parties of the first part will pay the said installments of principal and interest when the same fall due and at the place and in the manner provided in said note and contract, and
