R.R. thence southwesterly along the S. line of the R. of W. of the St.L. & S.F.R.R. a distance of 979.9 ft. to the intersection with the W. line of section 32, thence south a distance of 559.5 feet to place of beginning, containing 15.55±100 acres more or less.
