

## RESOLUTION FOR THE SALE OF UNUSED LANDS.

It appearing to the Board of County Commissioners of Tulsa County, Oklahoma, that Tulsa County is the owner of and has the possession of the following described real estate, situate in Tulsa County, Oklahoma, to-wit:

Beginning at a point 1363.0 feet north of the SW corner of section 32, township 20 N. range 13 E. running thence east a distance of 901.25 ft. thence north a distance of 944.3 feet to the S. line of the right of way of the St. L. & S.F.R.R. thence southwesterly along the S. line of the R. of W. of the St. L. & S.F.R.R., a distance of 979.9 feet to the intersection with the W. line of section 32, thence south a distance of 559.5 feet to place of beginning, containing 15.55 acres, more or less.

And it further appearing that said parcel or tract of land is owned by Tulsa County, and is unused, and is ground that is not needed for Courthouse or jail purposes, or for any other purposes by the County at this time; therefore,

BE IT RESOLVED, by the undersigned Board of County Commissioners that the same should be sold as prescribed by law, as unused lands belonging to the County, not needed for court house or jail purposes by the County and

Be it further resolved, that this resolution be published as prescribed by law, and a copy of same be certified by the County Clerk to the Judge of the District Court of Tulsa County, Oklahoma, That said Judge be requested to appoint three disinterested house holders of said County to appraise said real estate, and said appraisement to be returned by said appraisers to the Board of County Commissioners of Tulsa County, for their further action.

Now, therefore, I, the undersigned, Connelin, Judge of the District Court in and for said Tulsa County, Oklahoma, acting under and by virtue of said resolution, do hereby appoint Arthur Antle, M. A. DeVinna and John L. Smiley, each of whom are disinterested householders and taxpayers in and for Tulsa County to appraise the property described in the resolution hereto attached; that they be duly sworn <sup>according</sup> to law before they make said appraisement and after making it they will make a return thereof to Lewis Cline, County Clerk in and for Tulsa County, and ex-officio Clerk of the Board of County Commissioners of said County.
