RE-SALE TAX DEED.

Know all men by these presents, that, whereas, it appears from the records of the office of County Treasurer of Tulsa County, State of Oklahoma, that the tract, parcel or lot or land lastly in this indenture described was offered for sale at public auction on the 1st day of November, 1920, at the office of the County Treasurer in the Court House in and for said county for the taxes levied thereon for the year 1919, and it appearing that the said lands were legally liable for taxation, and had been duly assessed, and properly charged on the tax book or duplicate for said year, and had been legally advertised for sale for said taxes, and there being no other bidder therefor offering the amount due thereon, the same was by said County Treasurer on said date bid off in the name of said County of Tulsa, State of Oklahoma, for the sum of \$121.01 the same being the amount of taxes, penalties, interest and costs due and unpaid on the following described tract or lot of land returning delinquent for non-payment of taxes, costs and charges for the said year to-wit:

Dickey the undersigned County Treasurer of said County, pursuant to said advertisement, offered at sale at public auction for cash at the office of the County Treasurer in the Court House in and for said County of Tulsa, where by law the taxes are made payable and was then and there sold to W. E. Hardesty in the manner required by law, for \$83.00, he being the highest and best bidder therefor, and the said sum being the highest amount bid therefor, and

Whereas, the owner of said property so sold at said re-sale has not paid to the County Treasurer the said delinquent taxes, penalties and costs so accrued on said
