Witnesseth, that the said party of the first part, for and in consideration of the premises and the sum of \$83.00 in hand paid, hath granted, bargained and sold, and by these presents doth grant, bargain, sell and convey unto the said party of the second part, his heirs and assigns forever, the tract or parcel of land so sold at resale, as aforesaid, and described as follows, to-wit:
