THIS AGREEMENT made and entered into this 18th day of August, 1922, by and between St. Louis-San Francisco Railway Company, hereinafter called "Lessor" party of the first part, and Ryan Motor Company, a corporation organized and existing under and by virtue of the laws of the State of Oklahoma, hereinafter called "Lessee" party of the second part, the term "lessee" referring to and including each and every of the parties of the second part; ^{huto} witnesseth:

1. The lessor, in consideration of the covenants and agreements hereinafter mentioned, to be kept and performed by the lessee, hereby leases unto the lessee the following described piece of parcel of land lying within and being a portion of Lessor's right of way of station grounds, at Tulsa, Tulsa County, Oklahoma, described as follows:

Beginning at a point at the intersection of the southerly right of way line of St. Louis-San Francisco Railway Company with the west line of Main Street at Tulsa, Tulsa County, Oklahoma; thence northwesterly measured along the northerly production of the west line of Main Street 142.3 feet; thence
