ASSIGNMENT OF OIL AND GAS

MINING LEASE.

GILLESPIE AND SONS COMPANY all of his right, title and interest therein and thereto, hereby covenanting, for himself, his heirs, assigns and legal representatives, with said Assignee, its successors and assigns, that he is the lawful owner of said lease and rights thereunder, and of the personal property thereon, or used in connection therewith; that he has good right and authority to sell and convey the same, and that said rights, interest and property are free and clear from all liens and encumbrances.
