AGREEMENT, Made this 14th day of December, 1922, by and between Edith M. Hayden / 977 South Westmoreland Avenue, Los Angeles, California, parties of the first part, lessors, and The Prairie Oil and Gas Company, of Kansas corporation, of Independence, Kansas, party of the second part, lessee,

WITNESSETH: That the parties of the first part for and in consideration of the covenants hereinafter set forth, and of the further consideration hereinafter mentioned, have leased and let and by those presents do lease and let unto the said second party, its successors and assigns, all that certain tract of land situate in the county of Tulsa, State of Oklahoma, to wit:

The West Half ($W\frac{1}{2}$) of the East Half ($E\frac{1}{2}$) of the southeast quarter ($SE\frac{1}{4}$) of Section Twenty-nine (29), and the Northeast Quarter ($NE\frac{1}{4}$) of the Southeast Quarter ($SE\frac{1}{4}$) of Section Thirty-two (32), Township Twenty-one (21) North, Range Thirteen (13) East, containing eighty (80) acres, more or less,

with the exclusive right to the use of the surface of said land for agricultural purposes and the exclusive right to the use of any and all dwelling houses, buildings and improvements, situated and located thereon.

TO HAVE AND TO HOLD the same unto the party of the second part, its successors, and assigns, for the term of One (1) year from January 1st, 1923, and at its option from year to year thereafter at the annual rental of Eighty (\$80.00) Dollars to be paid yearly in advance

THIS AGREEMENT shall extend to and be binding upon the heirs, executors, administrators, successors and assigns of the parties hereto.
