

434 shall be borne by them, their heirs and assigns in the same manner and under the same plan heretofore set out; and that in case the said party wall or any portion thereof shall be rebuilt, it shall be erected on the same location where it now stands, to be of the same size, of same or similar materials and of like quality.

In case either party hereto desires to build the said party wall higher or longer, he may do so, and the other party when he desires to utilize the extension so constructed, shall pay for the same pursuant to the method and plan heretofore set out until payment is made shall have a lien on the other party's property therefor.

This agreement shall be perpetual and shall at all times be construed as a covenant running with the lands and shall be binding upon the parties hereto, their heirs and assigns.
