220544 C.J. COMPARED RELEASE OF OIL AND GAS LEASE.

WHEREAS, on January 11, 1916, Harry V. Meathers and W. Murdock assigned to F. R. Winters an undivided 3/8ths interest in and to the above lease, which assignment was recorded March 3, 1916, in the office of the Register of Deeds of Tulsa County, Oklahoma, in Book 189, page 80; and,

WHEREAS, Harry V. Meathers and W. Murdock assigned to W. J. Sheppard , on January 11, 1916 , undivided 1/8th interest in and to the above lease, which assignment was recorded on March 3, 1916, in the office of the Register of Deeds of Tulsa County, Oklahoma, in Book 189, page 80; and,

WHEREAS, the terms of said leasehaving expired and the above named lessees and assignees desire to release the same;

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS That Harry V. Meathers and W. Murdock, lessees, and Allen A. Pew, J. R. Cole, F. R. Winters and W.J. Sheppard, assignees, for and in consideration of the premises and in the exercise of their rights under said lease and the assignments thereof, do hereby give notice to the said lessors that they and each of them do hereby cancel, release, relinquish and surrender unto the said Ralsa F. Morley and Augusta M. Morley, his wife, lessors, all of their right, title and interest in and to the above and foregoing described lease, and the said lessees and assignees, and each of them, do hereby surrender possession of same unto the said lessors, their heirs , assigns, and legal representatives.
