WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

THAT T. D. Trickey and Helen J. Trickey, his wife parties of the first part in consideration of the sum of Two Thousand and no/100 DOLLARS, in hand paid, the receipt of which is hereby acknowledged, does hereby grant, bargain, sell and convey unto C. A. wandt grantee, party of the second part, the following described real property and promises, situated in the city of Tulsa, Stateof Oklahoma, to-wit:

Lot Thirteen (13) in Elock One (1) in Maywood Addition to the City of Tulsa, Oklahoma, according to the official plat thereof, duly recorded in the office of the County clark of Tulsa county, Oklahoma, together with all the improvements thereon and appurtenances thereunto belonging;

TO HAVE AND TO HOLD SAME AND WARRANT THE TITLE thereof unto the said party of the second part, heirs and assigns forever, free, clear, and discharged of and from all former grants, charges, taxes, judgments, mortgages and other liens and encumbrances of whatsoever nature; subject, however, to the following conditions, to be in force and effect for ten years from the date of the exectuion of this instrument; that the said premises shall not, nor shall any part thereof be used to erect or maintain thereon any duplex or apartment house, factory or business building nor any other non-private residential structure, except such incidental or subsidiary buildings as are ordinarily used on private residential premises; that no residence that shall cost less than \$4000.00, including subsidiary buildings and improvements, shall be built on said premises hereby conveyed; that not more than one residence shall be built on any one of said lots; that no building or any part thereof except steps or entrance approach without roof shall be built or extend within -----feet of the front line or closer than-----feet of the side street line; and no garage, servant's house or other subsidiary buildings shall extend within ----feet of the front line or within----feet of the side street line;

That no part of the lot or lots hereby conveyed shall ever be sold or rented to, or occupied by, any person of African descent, known as negroes; provided however, that the maintenance of servant's quarters and their use and occupation by servants of the owner or lessee of the lot or lots hereby conveyed, shall not be considered a breach of this condition:

All of which restrictive conditions, the said grantee, heirs, and assigns covenant to observe both towards the said grantor and towards all present and future owners and lessees of lots or parcels of land in said Maywood Addition to the city of Tulsa, Oklahoma; and do hereby acknowledge full notice and knowledge of similar restrictive conditions having been or which are to be imposed upon all lots or parcels of land sold, or to be sold, of said Addition.
