made in the payment of said note, or any part thereof, or any of the interest, thereon when due or any of our dues as stockholder when due and the same shall remain due for six months, or if the parties of the first part shall become indebted to said Association in a sum equal to the gross amount of dues, interest, fines and other charges for six months, according to the Bylaws of said party of the third part, then this deed shall remain in force and the whole of said indebtedness shall become due and payable.
