THIS INSTRUMENT, Made this 7th day of February, A. D. 1923 between Julia B. Jenkins and H. B. Jenkins her husband of Osage County, in the State of Oklahoma, of the first part, and Robert Gisele of the second part:

WITNESSETH, That said parties of the first part, in consideration of the sum of One (\$1.00) DOLLARS the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell, and convey unto the said party of the second part his heirs and assigns, all of the following described real estate, situated in Tulsa County and State of Oklahoma, to-wit: Lot Twelve (12), Block Three (3) Barton Addition to the City of Tulsa, Oklahoma.

WITNESSETH, That the said parties of the first part, in consideration of One Dollar and other valuable considerations, the receipt whereof is hereby acknowledged, and the further consideration and as a condition of this deed to which the grantor herein by accepting this deed assents and agrees: that the lot or lots hereby conveyed shall not within a period of ten years from this date be used for any other than residence purposes; that no residence that shall cost less than \$3,500.00 including subsidiary buildings and improvements shall be built on the lot or lots hereby conveyed; that one residence only shall be built on said lots; that
