And now on this 10th day of February, 1923, the above entitled cause comes regularly on for hearing, upon the petition of Sandy Johnson, Mollie Johnson and Emma Johnson, praying for the approval of a certain quit claim deed duly made and executed by them on the 16th day of January, 1925, to one H. H. Bell, of Muskogee, Oklahoma, conveying all their right, title and interest in and to the following described land situate in Tulsa County Oklahoma, viz

Lots Nine (9) and Ten (10) in Section Seven (7) Less Six and 58/100 (6.58) acres right of way of the A. V. & W. Ry Co. and lots One (1) and Two (2) less Six and 69/100 (6.69) acres right of way of said A. V. & W. Ry Co. and the Northwest quarter of the Northwest Quarter of the Northeast quarter, and the North Half of the Northeast quarter of the Northwest quarter of the Northeast quarter, in Section Eighteen (18) all in township Nineteen (19) North , Range Twelve (12) East; and Lots Five (5) and Six (6) less Five and 74/100 (5.74) acres Right of way of said A. V. & W Ry Co. in Section Thirteen (13) Township Nineteen (19) North Range Eleven (11) East, containing One Hundred Thirteen and 59/100 (113.59) acres, more or loss, according to U. S. Survey thereof.

And petitioners appear in person and with their attorney of record herein John D. Wakely, and the Hon, Peter Deichman, United States Probate Attorney also appears , and the petitinners and other competent witnesses are sworn and examined upon their oaths, and the Court having heard the evidence herein and being fully advised in the premises, finds;

That one Unah Johnson, full blood Creek Roll 9788, was heretofore seized and possessed of his Creek Indian right to the above described lands, as a Creek Indian Allotment, and that he died at the age of eighteen months, on or about september 3rd 1899, unmarried, intestate and without issue; that his mother Jinnie Johnson died November 6th 1909; that the petitioner Sandy Johnson is the father of said unah Johnson, and the petitioners Mollie Johnson and Emma Johnson are the sisters of the said Unah Johnson; and that said petitioners now before this Court are the sole and only surviving heirs at law of said deceased allottee Unah Johnson.

The Court also finds that on March, 4th 1907 a warranty deed was duly executed by said Sandy Johnson conveying the above described lands to one D. L. Sleeper, and said deeds also purports to have been signed by said Jinnie Johnson; that thereafter some question agrose as to the due execution of said deed by said Jinnie Johnson, and which has necessitated the conveyance herein sought to be approved, although it satisfactorily appears that said deed running to D. T. Sleeper was on April 2nd. 1907, approved by James Rudolph garfield, Secretary of the Interior, since which time the petitioners have been out of possession of said
