Vire and Ella Jane Vire of Tulsa, Oklahoma, his wife, hereim fter designated as Parties of the First Part and Emile Offenbacher of Tulsa, Oklahoma, hereinafter designated as Party of the Second Part:

WITH ESSETH:

That, whereas on the 20th day of November, 1922 Parties of the First Part executed to Sam Kornfeld a Gas Lease situate in Tulsa County, Oklahoma, covering:
