or any other than residence purposes; that only one residence shall be built on one lot; that no part of the lot or lots hereby conveyed shall ever he sold or rented to or occupied by any persons of African descent, commonly known as negroes, except that the building of a servant's house to be used only by the servants of the owner or owners of the lot or lots hereby conveyed, COMPARED shall be considered a breach of the conditions hereof.

This deed is made for the purpose of rescinding and holding for naught, the "forfeiture clause" contained in the deed heretofore made by the grantors to the grantee, deted August 3rd, 1922, recorded in Book 376 at page 428 in the office of the County Clerk of Tulsa County, Oklahoma.

It is further understood and agreed that these restrictions are covenants and shall be annexed to and run with the land, and either the grantors herein or any owner of any real estate in Ridgewood Addition to the City of Tulsa, Oblahoma, shall have the right to enforce said restrictions in any court of competent jurisdiction, either by suit or injunction. to prevent the violation of such restrictions, or to recover damages for a violation of such restrictions.

And said parties of the first part will WARRANT AND FOREVER DEFENT the same unto the said party of the second part, his heirs and assigns, against said parties of the first part, their heirs or assigns and all and every person or persons whomsoever, lawfully claiming or to claim the same.
