## RENTAL CONTRACT.

COMPARED

This agreement made and entered into, this October 21st 1922, between Mose Jefferson of Broken Arrow, Oklahoma, party of the first part and J. L. Moore of Broken Arrow, Oklahoma party of the second part:

Witnesseth: That said first party has this day let and leased unto the said second party, for the term of one year from the 10th of January 1927, the following described real estate, for agricultural purposes to wit:

S2 of SW4 of Section Nine, Township 18 North, Range 14 East, Indian Base and Meridian,

reserving however to the first party three acres in the South east corner of said tract, including the house. And that the consideration for said lease is the sum of One Hundred Dollars, cash in paid to the first party by second party, receipt of which sum is this acknowledged as having been received by first party from the said second party.
